(d) In Page 5, in paragraph 1.6-

(i) In line 1, *for “the CD/Applicants”, “the
CD/Applicant” shall be substituted;*

(ii) line 3, *for “01.09.2024”, “17.09.2024” shall be
substituted;*

(e) In Page 6, under in paragraph 2.2, line 3, *for “as
well as”, “and substituted” shall be substituted;*

(f) In Page 7, in paragraph 2.3, line 10, *for
“25.02.2022”, “24.05.2022” shall be substituted.*

(g) at Page 13, under **“ORDER”**, in line 4, *for “Private
Limited”, “Power Limited” shall be substituted.*
